EARLY DISPUTE RESOLUTION IMPACT

Over the past few years, DRCs across the state have gained valuable insight into the current challenges facing housing providers and tenants. For decades, DRCs have provided an efficient and cost-effective pre-filing mediation option for settling tenant-landlord financial and behavior issues. Consider the impact that DRCs have had on the larger issue of housing stability in communities throughout the state. Housing providers often prefer to reduce legal costs and prevent tenant eviction by discussing repayment options or working through behavior issues in advance of taking court action. Tenants appreciate the opportunity to problem solve housing solutions with their landlord through an impartial facilitated process.

Funding for DRCs to provide FREE pre-filing resolution for housing issues removes barriers and increases access for any tenant in need and for both small landlords and larger property managers providing housing for individuals and families.

Wenatchee Valley DRC's team of volunteers and staff offer efficient and timely conflict resolution services to Chelan and Douglas County residents. The DRC on average schedules a mediation within 2 weeks of connecting with both landlord and tenant.

The settlement rate for tenant—landlord mediations is typically above 80%

WHAT HAPPENS WHEN ERPP SUNSETS ON JUNE 30, 2023?

On June 30, 2023, RCW 59.18.660 and, unless updated or renewed, local Superior Court standing orders will end. Landlords will no longer be required to issue an ERPP notice to both tenant(s) and the local DRC. Landlords will no longer be required to participate in early resolution programs including tenant referral, mediation, or conciliation even if the tenant is requesting these services. A certificate of participation in ERPP issued by the DRC within 14-21 days will no longer be required for a landlord to file an unlawful detainer (eviction) action for non-payment of rent with the local Court.

Resolution Washington (statewide association of DRCs) and Wenatchee Valley Dispute Resolution Center continue to see value in early dispute resolution services to support the prevention of evictions, reduce the unlawful detainer court dockets, and promote accessible resolution options to all community members.

We continue to support complementary affordable housing and housing stability approaches including emergency rental assistance, pre- and post-filing access to legal aid for unlawful detainer (eviction) cases, and efforts to expand affordable housing.
